Malvern conservation appraisals

Martley is to be the first in Malvern Hills District Council's programme of conservation area appraisals for 2006, which I have been asked to carry out. So I thought I would make my first contact with those living in the conservation area via The Villager.

Malvern Hills District Council has 21 conservation areas within its area, and a number of them have not been resurveyed, or appraised, for over 20 years. The Best Practice guidance is that they really should be appraised every five years or so, but (like virtually every other authority in the country) this has rather slipped. Now, however, the bull has been taken by the horns and the Development Plans and Conservation section of the Council has drawn up a programme of conservation area appraisals for 2006/7. Priorities were considered but, as it happens, the first three of these appraisals will be carried out in Martley, Kempsey and Hallow, with Martley to be surveyed in February 2006.

You will probably see my colleagues


Nicky Wardroper, Chris Mayes and myself around the village in February, clutching plans and taking notes. We will be carrying out the appraisal, and this will hopefully be presented in drawn-up form some time in April, within the Village Hall, and also possibly brought to a public meeting in the Village Hall.

Your views

Your input, however, is vital and would be welcome at any stage, and you are invited to make your views known on the appraisal. Perhaps I can just make clear, however, what the appraisal involves. It's a character assessment of the existing conservation area (you may know the boundaries and whether you live within them), but also of its landscape setting, and an assessment of how it has changed since 1981, the last time it was appraised. We would therefore be interested to know your views on the Martley conservation area, its strengths and weaknesses and whether it should be extended, stay the same or possibly have tighter controls on the odd minor works that you may consider have eroded the quality of the conservation area in the past 25 years. What an appraisal is not is a rescheduling of the Local Plan designations or a re-drawing of the Housing Settlement boundary of the village, both of which were considered within the recent Local Plan Inquiry to the emerging Malvern Hills District Local Plan and which were subject to lengthy public consultation. We are also not asking for views on the development merits of particular sites within the village. This would more properly be addressed to my colleagues, the Planning Officers. An appraisal would be looking at how the conservation area has changed or deteriorated and how it could be enhanced, not at where housing or particular uses should be sited. If you have any views on this process or any good ideas as to how Martley could be enhanced, please let me know at the postal or e-mail addresses set out below.

In Memoriam

Many of you who read this will have known Don Taylor, some of you will have known him better then me, and some will not have known him at all. Those that did not know him are the unlucky ones. To say Don Taylor was larger than life is a bit of an understatement. In a world where we are told there are no characters left, he certainly was one.

Born and brought up in Martley, he never forgot his roots, and loved the place, he often complained about it, and strived to make it better, but he was often quoted as saying: "There's only one Martley in this world."

Don will be remembered by many for his passion for sport; cricket and rugby remained his great interests in later life. He was often to be seen at Sixways and at New Road, and he loved the company of sporting people.

President's Eleven

He was a good cricketer, playing for Wichenford, Clifton and latterly for Martley, and always enjoyed getting his President's Eleven out to play the locals, and you were never sure who would turn up, a Test player alongside someone who turned out once a year. But it was always a highlight of the sporting summer, and there was always a crate of ale in the back of the 'dilley'.

He was a personal friend to many a top sportsman. When the Chantry opened new cricket nets he asked Ian Botham to come and do it, Gareth Edwards; Basil D'Oliveora and the like were all his mates.

He was as happy in the local pubs; whether it was at the Long Room at Lords or the back bar of the Lion at Clifton, Donald would be happy and would find someone to laugh and joke with.

And what a loud and infectious laugh. He also loved his shooting, and was at his happiest in the Teme valley, on Berrow Farm at the shoot he ran, and was always off somewhere in the season with his gun, getting back to open the bar in the Village Hall for the Airgun team.

Don was a great family man, he and

Margaret were proud of their lads and their families and grandchildren. He was also a very astute businessman.

Anyone who can help take a one-lorry company to the heights that Taylors of Martley has achieved, with more than 200 trucks on the road, knows what he's doing.

He had some great phrases that he lived by: "Good old son" when you'd done well; "One job at a time" and when it was completed: "Job's done." There are some, including me, who felt Donald's other side as well: "What do you mean son you've crashed the tractor?" And when his head started to wobble, stand by! He liked people to be upfront with him, and he could often be blunt, but he always meant well and could be a very forgiving man.

These few words are just a scratch at the surface of the man who was Don Taylor; to put it all down on paper would require a book, or two. Like many others, I am proud to say that I knew him and will miss him.

Martley's past

At the Parish council meeting on 27 August 1918, the Rev J F Hastings raised a question regarding the Parish Boundary with Doddenham as shown

on the 1840 Tithe Map. A committee was formed to take the measurements. What follows is the exact report of that committee on 7 February 1919.

"This committee consisting of Messrs Hastings, Hewlett and Humpherson inspected the said piece of land and, according to their measurement, it was 27 perch belonging to Martley and 16 perch to Doddenham Parish. It was proposed by the Chairman, seconded by the vice-chairman that the Clerk be instructed to write to the Overseers of Doddenham asking them to hand over (!!) the piece of land and cottage now tenanted by Miss Berry to this Parish as shown by the Martley Tithe Map." (They didn't add 'or else!')

Martley National School -Admissions Register

Does anyone have any knowledge of the whereabouts of the Martley National School Admissions Register for the turn of the 19th/20th Centuries?

Worcestershire CRO has advised that although it holds some records for Martley School, admissions registers have not been deposited and, if extant, may still be held at the school.

My interest stems from family history research into a Deane gamekeeper and what appears to be a possible family crisis resulting in dispersal of his children for a spell during 1905. Daughter Dorothy was admitted initially to Broadwas School in May 1904, but is recorded re-admitted to Broadwas

from 'Martley N.' in April 1905.

Foresters brass band

With reference to the enquiry from Barbara Campbell about the Martley Foresters Brass Band, I do not know anything about the band, but I do know that there was a branch of the Ancient Order of Foresters that used to meet at the Crown.

As far as I know they had stopped meeting by the time I came to the village in 1976, but G Howard Heaton (known as Jim), who lived at the Tee, and after whom Heaton House was named, told me that he was or had been a member.

I know about the branch because the Royal British Legion, which used to meet at the Admiral Rodney moved to the Crown. This was before the first of the two revisions to the layout. At that time, one could enter through the front door, or through the side door to the left.

Inside on the left, behind the left hand bay window, was a small room where we met, and from the boards on the wall I am sure the Foresters met there also. The boards had names of prominent members, and one board was a memorial to those members who served or died in the First World War. I do not recall any of the details.

I also remember a picture, or more likely a photograph of a parade of members with a huge banner. The sort of banner held on two poles with guy ropes.

I imagine that a branch of the Order which was strong enough to have a large banner could well have attracted a band. Remember, Martley was the centre of a Rural District Council, of which Jim Heaton was chairman for some years. I am sure that based on these sketchy facts, a few enquiries from older members of the village, like Jack Bradley, Beth Williams or Alan Boon might elicit more information.

Expert map readers wanted

I was wondering if there is anybody in Martley who is proficient

in reading old maps. We are trying to find bridle paths that have fallen into disuse. We have no alternative but to ride on the road and we don't like it any more than the drivers who have to slow down to pass. Indeed, as some don't it makes riding even more dangerous than it is! The map I have is dated 1904 and is very interesting; it shows a sanatorium on the right side of Ankerdine Hill as you go down. This must have had access, as would the old court house; suitable for horse drawn vehicles, it would not have been possible for horses to have pulled up the existing Ankerdine road. It looks to me as if going down the Horsham road would have been the obvious route and would indeed marry up with the Suckley bridle path/road.

As I am sure you are aware the traffic both in volume and size has increased dramatically over the last couple years on our roads, so any help enabling all of us to ride off them would be appreciated. It would help if people who were to use a way (if one were found) could contact me so that I had numbers to send to the relevant bodies! PLEASE do try.

Martley Parish Council

Monday January 9, 2006 at the memorial hall

Present: Cllr. Mr. D. Cropp (Chairman, Cllr. Mr. G. Taylor (Vice Chairman), Cllr. Mrs. D. Goodyear, Cllr. Mr. R., McHugh, Cllr. Mr. J. Slough, Cllr Mr. G. Coombey-Jones, Cllr. Mr. M. Nott, Cllr. Mr. N. Stammers.

In attendance: Mr. T. Pearsall (Clerk to The Parish Council), 10 members of the public.

The Chairman asked all present to stand and spend a few moments in silence as a mark of respect for Mr. Don Taylor who died on 26 December, 2005. Mr. Taylor was a former vice chairman of this council and had recently been presented with The Freedom of Martley.

The Democratic Period/Public Ouestion Time

The Chairman invited all present to ask questions or make statements about Parish business, the following points were raised:

A question was asked why the weight limit proposed for Ankerdine Hill had been delayed. District Cllr. B. Williams explained the background and referred to correspondence with WCC Highways. The Clerk agreed to send a copy of the letter from Mr. M. Davies (WCC Highways Partnership Manager) to Mrs. Martin.

A further question was asked about the reasoning behind the proposed re-

moval of the white lines; the Chairman explained how perceptions of danger change when clear markings are removed.

A question was asked about the latest position on the renumbering of St. Peters Drive, because incidents are still occurring causing problems for neighbours. The Clerk to follow up with MHDC.

A question was asked about the provision of affordable housing in Martley. The Chairman identified the various difficulties with land provision, but confirmed that this council remains committed to early provision in this parish. The committee producing the Local Plan will be seeking to include affordable housing.

The Parish Council Meeting was opened by the Chairman at 8:28 pm.

The Chairman explained that item six on the agenda (land acquisition) would be held at the end of the meeting, in camera, due to the sensitivity of the issue.

Apologies: Apologies were received from Cllr. Mrs. M. Randall; these were accepted. Apologies were also received from County Cllr. A. Davies.

Declarations of Personal or Prejudicial Interests: The Clerk reminded everyone of the need to declare interests and to keep their list up to date.

Minutes of the last meeting held on 5th. December 2005: It was resolved to accept the minutes as a true record

Parking on the Playing Field: The Chairman explained the need for extra

parking at the Memorial Hall and confirmed that no grants are available for this. It was agreed that the provision of notices would be explored (to remind car drivers that it is illegal to park on the pathways). In addition, the Playing Field Association would be encouraged to write to visiting teams explaining that parking is limited and that some vehicles may be parked using the top gate.

Parking in the centre of the village: No simple solution is possible, therefore no action can be taken at this time; it will be kept under review.

District Councillor's Report: District Councillor Mrs. B. Williams announced that the "top slicing" of funding for the Development Control dept. had now ceased and full funding will be available.

The "speaking time" for Parish and Town Councils at planning meetings will now be three minutes.

Parish Paths Warden's Report

January 2006

The most anticipated meet of the year usually resulting in a full turnout of members. In the event, being so close to Christmas, several of us were busy and so those on show were able to indulge to the full in the delights provided by Audrey Trumper. Marvellous mince pies and a warming drink of coffee. One problem; at this time of year Audrey digs out a bottle of milk she must keep under the sink or in the shed. At any rate, the 'milk' is so old, it seems to have fermented and gives to the coffee a rather unusual taint. Still, you can get used to anything!

Work completed on 18th December included a new bridge with handrail on FP70 below Woodside Cottage in Newtown, where the ditch underneath had been excavated so deep you can't see the bottom. Also replacement of missing signposts in the Newtown area.

You might recall that in November we replaced a signpost on B4204 pointing towards the Tee. Two weeks after, the post had been removed and now is hidden behind the hedge. In Hollins Lane, three posts have been removed and lie, neatly stacked, by the side of the lane.

the time to repair the work of petty vandalism. Interference with any sign, whether on the M5 or a local footpath is a criminal offence with a potential fine of £1,000. To replace these four signs will take almost a full session for the group, delaying other important work that we have scheduled.

Cllr Britten - Long chaired the meeting.

Highways

This agenda item was brought forward at the request of the parishioners in democratic half hour. The clerk was asked to chase-up the highways department with regard to the missing sign at Dirty Lane.

Guises Lane and Rosses Lane Wichenford.

The first draft report on the status of Rosses Lane and Guises Lane were discussed.

The clerk was asked to send a letter to the legal department and the environmental department with the additional evidence that has been found, and further correction that needs reexamination.

The parish council have written to the highways department fully supporting the proposed prohibition of all motor vehicles on Rosses Lane and Guises Lane. The parish council along with villagers and parishioners support the closure recommended taken as a result of the archaeological and ecological report, and wish to see permanent closure notices to motor vehicles on both Rosses Lane and Guises Lane.

B4204.

The proposed traffic safety measures on the B4204 were discussed. Although the highways department want to put advisory speed limit signs and alternative traffic management measures to highlight the specific hazards along the route, the parish council feel that statutory speed signs would be more effective.

The measures proposed are:

Bend warning signs on yellow backgrounds with advisory maximum speed plates.

Slow carriageway markings at strategic locations to emphasise the importance of the warning signs.

Central hatched markings to give a narrowing effect at key locations.

The parish council have requested a meeting with the highways department to discuss the signage improvements. They would like the central markings to be solid white lines as they feel these will be more effective.

Residents at Kenswick Manor have concerns about the road as 7% of users exceed the 60mph limit. It was suggested that we contact the police and ask for a speed camera at peak hours. It was also suggested that the speeding problem at Castle Hill could be considered in conjunction with the Masons Arms planning proposals.

Pancake day

Pancake Day is the Tuesday before the beginning of Lent.

Originally a religious festival, it's now also an excuse to get out the frying pan and cook up a feast.

How did it start?

Shrove Tuesday is the day before Ash Wednesday, the first day of Lent. Traditionally, families would use up their luxury foods like milk, sugar, eggs and butter, before the 40 days of fasting began.

Why shrove Tuesday?

The word shrove comes from the ritual of shriving. People would go to church and confess their sins to a priest, who would grant them absolution. The shriven individual would then be in a pure state, ready for the Lenten period of fasting and abstinence.

Skipping and flipping

On Shrove Tuesday in Scarborough, locals enjoy the customs of Ringing the Pancake Bell and Shrovetide Skipping. Long skipping ropes are set up across the promenade and up to 10

people have to skip at once! At St. Columb Major in Cornwall, rival villages play Hurling the Silver Ball, using a ball of applewood covered in silver. Meanwhile, pancake races take place in Winster (Derbyshire), Bodiam (East Sussex), and Olney (Buckinghamshire).

Pancake races

Pancakes are eaten and pancake races are held in villages and towns. The object of the race is to get to the finishing line first, carrying a frying pan with a cooked pancake in it whilst flipping the pancake a pre-decided number of times. The skill lies not so much in the running of the race but in flipping and catching the pancake, which must be intact when the finishing line is reached.

How to make pancakes

Ingredients: plain white flour: 8 oz, unsalted butter: 1 oz, milk: 1 pint, small pinch of salt, 2 medium eggs Method: Mix the ingredients together to make a smooth batter and cook the pancakes in a hot frying pan until golden brown on both sides.

Good things to put on pancakes

Traditionalists favour lemon juice and sugar, but you could also try golden syrup, cinnamon, maple syrup, jam, fruit, yoghurt or even Marmite! Alternatively, why not adopt a continental approach and go for cheese, ham and mushroom or cream cheese and spinach.
